## Matters arising from the minutes of the previous meeting:

- Aubert Centre Liam Greer has explained the cost of the lease.
   Valuation has been completed.
- SH security micro switches have been installed on the side doors. Lights on indicate that there is a door open. Progress has been made on the installation of security cameras. Security cameras progress is being made.
- Managing finances the use of Armourguard to transport money to Palmerston North each week is working well.
- Mission Centre (MC) parishioners are in favour of the development of the MC. Fr Marcus
  will talk with Morgan Flynn about ideas for making optimal use of the space in the Mission
  Centre. Following this a sub-committee will be established. There will likely be an ongoing
  second gold coin collection at masses throughout the CPH.
  - Brian will apply to the Hastings DC for rates relief considering the MC is not being used as a residential facility.
  - MC will need to be included in the H & S report for SH.
  - A suggestion of having a sacred space within the MC will be considered.
- Immaculate Conception Church at Pakipaki Bill P and Fr Marcus will visit to assess the maintenance requirements.
- OLOL presbytery tree work is being completed.
- OLOL heating new heater is working well and Brian will investigate the cost of extra heaters to replace the existing system.
- Church signs for SPC and SH these are ready to be installed. Fr Marcus will clarify what needs to be included on these signs with the Parish Council
- Four donated computer screens for office staff are greatly appreciated.
- Fibre has been installed for the SPC presbytery.
